The cookies will not harm your computer equipment and/or communication tools. In the following cases Your personal data may be collected in order to enhance your experience of using the online services. It will remember the unique language and customize the usage information according to your needs to confirm your unique characteristics, security information and services you are interested in. Cookies are also used to measure traffic to online services. Personalizing your content based on your previous and current browsing behavior and may be for advertising purposes.

4. Purpose of use of cookies

- 4.1 to study the behavior of your use of the website to be developed to make it easier, faster and more efficient.
- 4.2 To know the usage patterns and usage history of the website Information or services you are interested in and analyzed to improve service display ad content or promote appropriate activities including services that match your interests to increase your satisfaction even more.

5. Type of cookies

- 5.1 **Strictly Necessary Cookies** : These are cookies that are necessary for the website to function and are necessary to enable us to provide the Company's services. As you request, for example, cookies that allow you to log in to secure websites.
- 5.2 **Analytical / Performance Cookies** : These cookies allow us to remember and count the number of visitors to the website, as well as to help the Company determine the behavior of visiting the website.
